This Pomeranian is being sold for the purchase price of \$ _____. In addition, all shipping expenses are the responsibility of the purchaser. Once payment is received, the puppy is owned by the purchaser and all veterinary care will be the purchaser's expense. All payments are non-refundable and non-transferable.

This Pomeranian is being sold as a family companion with limited AKC registration papers. The puppy will be neutered/spayed before shipped/transferred to the new owner at the seller's expense. The new owner will receive microchip transfer information from the seller that will need to be completed before AKC ownership transfer is completed. This will ensure that all transfers are complete and that the puppy has an accurate record. Signature on this agreement also gives written authority from the new owner for the breeder to register the puppy and have the AKC registration certificate mailed directly to the new owner listed above.

Health Guarantee: The purchaser has 48 hours from the date of transfer/shipping to have the Pomeranian examined by a veterinarian of their own choice, at their own expense. If the vet exam reveals that the Pomeranian is diseased, the purchaser must contact the seller on the day of the office visit of intent to return the Pomeranian (along with a written statement from the attending vet as to the health problem). The purchaser will have 72 hours to return the Pomeranian for a replacement when one becomes available. Replacement is the only option. Any difference in price will be the purchaser's responsibility. Returning the Pomeranian will be at the purchaser's expense. There is no guarantee against accidents. No veterinary bills will be paid by the breeder/seller.

Congenital Disease: If the puppy dies of natural cause due to a life threatening congenital disease within two years of age, the purchaser must send proof of cause of death from a licensed veterinarian immediately upon death. Seller reserves the right to request autopsy results to confirm cause of death. If warranted, the purchaser will have the right to a replacement puppy of equal value when available. There is no refund of purchase price and no veterinary bills will be paid by the breeder/seller.

Under no circumstances is this Pomeranian to be placed in a pet store, an animal shelter, or any similar establishment. If the owner needs to find a new home for the Pomeranian, the breeder may be contacted for possible assistance.

This Pomeranian is sold with no warranties, either expressed or implied in an "as is" condition with no guarantees other than those stated herein. This agreement represents the entire agreement between the parties. This agreement shall be governed by the state of Michigan and all claims, disputes or other matters between the parties of this agreement shall be brought in Delta County Court, Escanaba, Michigan, USA. When breeder and buyer execute this agreement, it will be binding upon all parties, subject and pursuant to the terms and conditions herein.
